6) Selection will be done on Merit Basis and based on the following criteria:

- Merit Lists shall be prepared separately for each of the categories of posts. Total marks are 100 of which 90 marks will be allotted basing on the marks obtained in qualifying examination and 10 marks will be awarded for the age. Weight-age forage will be reckoned from 18 years of age of the candidate. 0.5 markwill be awarded for one completed year of age with a maximum of 10 marks. The age willbe reckoned as on 01-07-2024. (Example 1.If a candidate completes 20 years as on01-07-2024, he/she will be awarded 1.0 mark; Example 2.
