The shortlisted candidates to be called for document verification should, however, note that the above mentioned provisional selection lists are subject to the final decision in WP No. 5901/2019 filed before the Hon'ble High Court of M.P. and other respective cases/ W.P.s in the subject recruitments which are pending before the courts of law and also to the any further directives of Energy Department, GoMP & GAD, GoMP.

The shortlisted candidates called for appearing in the document verification process should, in their own interest, check their eligibility in all respects so as to avoid disappointment at any later stage. In case, it is found that the candidate does not fulfill the eligibility criteria his/ her candidature will be cancelled at any stage of selection or even after joining.

In case any shortlisted candidate does not report for document verification on the stipulated date as mentioned above, his/ her candidature will be rejected and his/ her name will not be considered for further allotment in waiting list and his/ her claim for selection/ appointment will automatically stand cancelled.
